Terms and conditions:

1. General Requirements

Regular courses are designed for adult learners. Participants must be at least 16 years of age and a proof of age should be furnished at the time of registration.

2. Course Fees and Terms of Payment

- 2.1) The contractually binding course fee is the fee stated in the price list at the time of registration.
2.2) Candidates are requested to register online according to the registration schedule & links mentioned on the web-site.
2.3) The fee collected includes course fee, book fee and others (including dictionary) with applicable GST.

3. Registration procedure:

The following documents are mandatory for registration and have to be produced on payment date

- Filled application form with email address.
- Copy of Passport/driving license/Voter's ID/Aadhar card.
- Screenshot of the online payment receipt.
- For level A2 and above, previous level course participant number & certificate of the last attended German language course. If no proof of previous level is available, then candidate has to appear for a placement test to assess the level to be admitted.

4. Cancellations, refunds and change of batch

- 4.1) In case of cancellations five working days prior to the start of the course, the course fee shall be refunded after deducting an administrative fee of Rs. 3,000/- per level.
4.2) In case of cancellation made in the last five working days before the course starts, only 50% of the total course fee shall be refunded.
4.3) Cancellations must be submitted via mail only with the receipt to the Language Department using the contact address indicated in the receipt. The refund process will take at least fifteen working days.
4.4) After the commencement of the course there is no possibility for a refund or adjustment of fee, irrespective of whether the participant has attended any class or not.
4.5) Should the Goethe-Zentrum, Coimbatore cancel a course, the full course fee shall be reimbursed.
4.6) Change of batch is not possible once the registration is completed.
4.7) Course fee is in no case transferable to another person.

5. Participation certificate

75 % attendance is mandatory for course participation certificate.
